CH 1 - Enduring Vision

Short Answer:

1. Where and when did the earliest contact between Europeans and Americans probably occur? What, if anything, resulted from the contact?
2. How did Native Americans' view of nature and land use differ from that of Europeans in the 1500's and 1600's?

Essay:

Discuss the differing ways of life of Native Americans living in the Arctic, the Pacific Northwest, California, the Great Basin, the Southwest, the Mississippi Valley, and the Eastern Woodlands. Explain how the physical environment influenced each way of life.

CH 2 - Enduring Vision

Short Answer:

1. Define the term Columbian exchange and give examples of the ways in which it affected the peoples, animals, and plants of Europe, Africa and the Americas.

Essay:

Compare and contrast the early 17th Century settlements of North America of the French, Spanish, Dutch and English.

CH 3 - Enduring Vision

Short Answer:

- 1) Describe the extent of the British, French and Spanish empires north of Mexico in 1700. How did they differ from each other in terms of settlement and economic patterns?

Essay

Discuss the evolution and spread of slavery in the Chesapeake colonies in the 17th Century. Why did African slavery develop there? How did the

gradual shift from plantation labor force made up of indentured servants to one of African slaves affect life in Virginia and Maryland?

CH 4 - Enduring Vision

Short Answer

- 1) What impact did the practices of colonial farmers in the 18th Century have on the environment of the Atlantic seaboard settlements?
- 2) Explain why the Spanish and French had more trouble attracting European settlers to their North American colonies than did the British.

ESSAY:

- 1) How much equality, liberty and self governance existed in the American colonies in the period 1700 - 1750? Back up your assessments with as many specific facts as possible. **(This essay can be 3 paragraphs)**
- 2) Historians have long debated the impact of Britain's mercantilist economic policy on the colonies. Explain the mercantilist economic theory and show how Parliament incorporated it into the Navigation system. According to CH 4, in what ways did the system hurt and benefit America? Does the author believe the harm outweighed the benefits?
